Keep the TSP informed of any changes in your address so that you continue to receive important information about your account. **Note:** Submitting this form will **not** change the address for your uniformed services TSP account, if you have one; you must make that change separately using Form TSP-U-72. PRIVACY ACT NOTICE. We are authorized to request this information under 5 U.S.C. chapter 84. Executive Order 9397 authorizes us to ask for your Social Security number, which will be used to identify your account. This information may be shared with other Federal agencies for statistical, auditing, or archiving purposes. It may be shared with congressional offices, private sector audit firms, spouses, former spouses, and beneficiaries, and their attorneys.
